**Entries will close on Thursday, April 15, 2010 at 7:00 PM EDT with the Test Secretary at the above address. No post entries and no phone or fax entries. Express entries must be sent with no signature required.**

Drawing for running order will take place at 8 PM, Thursday, April 15, 2010 at the above address. Notification of running order will be posted on the club website ([www.pvgrc.org](http://www.pvgrc.org)) and will be given by e-mail, provided an e-mail address is included on the entry form. **Preference will be given to Golden Retrievers currently untitled in the Stake(s) entered.** If the limit is not reached, the remaining entry will be filled with untitled dogs of other breeds, then with titled Golden Retrievers, and then with titled dogs of other breeds.

**All dogs will run under the GRCA Rules (which allows FCRSA rules for Flat-Coated Retrievers). Rules are available at <http://www.grca.org/events/field/wcwcx.html>. If you do not have internet access, please ask the Test Secretary for a copy of the rules.**

**Mechanical wingers may be used in the WCX Test.**

**RUNNING ORDER:** As per GRCA guidelines, all breeds will run under GRCA rules and will be assigned a running number by random order of the draw.

**BIRDS:** Pheasants and ducks will be used in the WC/WCX. Pigeons, ducks or bumpers (handlers' choice) will be used in the Pee Wee Hunter Stakes. **We reserve the right to use chukars if pheasants are not available.**

**PRIZES:** A rosette and duck band will be awarded to all WC and WCX qualifiers. Placement rosettes will be awarded for the Pee Wee Hunter Stakes

**ENTRY FEES: WCX - \$40; WC - \$35; Pee Wee Hunter - \$10  
(There will be a \$20 fee for returned checks)**

**Directions to the Test Site:**

**From the Washington Beltway:** Take Route 5 South toward Waldorf, then take Route 301 North to Cherry Tree Crossing Road, which is located across the road from the Veteran's Cemetery (approximately 4 miles north of Waldorf. Turn right on Cherry Tree Crossing Road and follow the signs to the test grounds.

**Other Instructions/Information:** Bitches in season are not allowed on the test grounds. Refunds will be made for bitches in season or injured dogs, if a veterinarian's certificate is provided to the Test Secretary no later than 10 days following the event.

No food is available on the grounds. However, food is available within 10 minutes drive of the site. Alcoholic beverages are not permitted on the site.

Non-Golden owners are responsible for handling the necessary paperwork for certificates and approval from the specific parent breed club.
